Public Holiday for Ronphos Handover, Wed, 1Jul2020, 9am-5pm.

Under Section 81, subsection (k) of the Public Service Act, Wednesday, 1 July 2020, 9am-5pm is declared a public holiday to be observed by the officers and employees of the public service and its instrumentalities in commemoration of the Ronphos Handover.

Notice of 20 per cent increase in import duty on tobacco and alcohol products from 1Jul2020.

Customs wishes to advise importers, customs brokers, other stakeholders and the general public of a 20 per cent import duty increase in the cost of tobacco and alcohol products from 1 July 2020.

For importers, brokers and other stakeholders:

From 1 July, import duties on tobacco and alcohol products will increase by 20 per cent.

The Nauru Government approved the increase on 4 June, with the decision in part to raise revenue to meet 2020-21 policy goals, but also, to drive behavioural change in the community.

Tobacco use and excessive alcohol consumption place a heavy burden on Nauru, in terms of rising health care costs, lost productivity of the workforce, sickness and early death from non-communicable diseases (NCDs) resulting from unhealthy lifestyle choices.

Customs will make available to relevant stakeholders via email a copy of the Customs Tariff (Alteration to Tariff) Regulations 2020, subsequent to its publication in the next issue of the Government Gazette.
