Owners or licensees of the abovementioned businesses must immediately cease their business operations.

Under *Section 17* of the *Business Licences Act 2017*, a person who operates a business on an expired licence must pay the following penalties on lodging an application for renewal:

- within 1 month from the date of the expiry of the licence - \$1,000;
- 2 months from the expiry date of the licence - \$3,000; or
- 3 months or more from the expiry date of the licence - \$10,000.

In addition to the above statutory penalty, a late fee of [\$100 / \$200, whichever is applicable] and renewal fee of \$300 must be paid before the renewal application will be considered.

A licensee must provide proof of payment of the penalty and the renewal and late fees to the Registrar of Business Licences. *[Payment must be made at the Nauru Revenue Office within 7 days from the date of service of this Notice.]*
