- 1. The House met at 10 a.m. in accordance with the resolution of the House made on Wednesday, 16th July 2008.
- 2. The Hon. Riddell Akua, M.P., Speaker of Parliament, took the Chair and read Prayers.

3. **Notice of Motion**

Hon. Frederick Pitcher (Minister for CIE) gave notice that at the next sitting of Parliament he shall move to present the *Nauru Phosphate Royalties* (*Payment & Investment*) *Amendment Act 2008*.

5. Ministerial Statements & Tabling of Papers

Hon. Mathew Batsiua (Minister for Health) made a statement to the House which reads as under:

- "1. That Sections 5 to 8 of the Bill are removed.
- 2. A new section 5 is inserted;-
- '5. The salaries and allowances of Members of Parliament, including Members of Cabinet and the President, shall be as set out in Schedule 1 to this Act.'
 - 3. Section 10 shall be removed and a new section 7 shall be inserted:-
- '7. The salaries and allowances of Members of Parliament, Members of Cabinet and the President, may only be amended by Parliament approving amendments to Schedule 1 of this Act.'
 - 4. Sections 9 and 11 of the Bill shall be re-numbered as sections 6 and 8.
 - 5. Schedule 1 shall be attached to the Bill.
