REGISTRATIONS AND TRANSFER OF REGISTRATIONS NOTIFICATION

The following keys can be used to identify the reason of registration or transfer of registration for each voter.

- 1. The District is registered as his or her place of birth in the Register of Births;
- 2. He or she is living in the District now and been living in the District for more than one(1) month;
- 3. He or she is living outside Nauru and immediately before he or she ceased to live in Nauru he or she had been living in the District for more than one (1) month;
- 4. Birth not registered and have never lived in Nauru;
- 4a. Birth not registered and have never lived in one (1) District for more than one (1) month.

That he or she has connection to the District through:

- 5. Nauru custom, customary links, and affiliation;
- 6. It is the District birth of his or her father or mother;
- 7. His or her father or mother is registered to vote in that District;
- 8. His or her spouse was born or is registered to vote in that District.
