Tsinia 27,881 the nearest figure which government should request should be 28,000? Why have they come and requested 30,000 instead of 28,000? Wonga question ngea.

Secondly, ngana mungana details ura totu ine, ura ouge iyon dogin audo 26,500 me iyon eiy 1,000 me meta ngea bita total me eiy 27,510 contrary ea bita won statement amea Minister for Finance.
